This process entails consistent endeavor, perseverance towards attaining personal goals, and unwavering affection and devotion towards one's familial unit.

Abdullah's research discovered that animated movies have the potential to facilitate children's ability to distinguish between concepts of good and evil (Abdullah, 2023).

One of the primary themes explored in the film is the concept of honesty. Within the cinematic production, a particular dialogue transpires, wherein a character utters, "You possess knowledge of the fact that your paternal figure was an individual of remarkable qualities. His demeanor exuded an air of self-assurance, such that upon his entrance into a given space, he commanded attention from those present." The individual consistently adorned himself with a pair of remarkably unattractive purple socks daily. In this utterance, articulated by an acquaintance of his paternal figure, the narrative unfolds regarding the genesis of the adolescence of Wilden Lightfoot. The depicted scene illustrates the transmission of information from the father's acquaintance to the individuals in question, pertaining to the inherent self-assured disposition commonly exhibited by Wilden Lightfoot. According to the theoretical framework proposed by Linda and Richard, conveying a message that is perceived as positive, despite the presence of danger or adversity, can be classified as a manifestation of courage. The sentence can be categorized as an expression of bravery, as Manticore demonstrates courage by navigating difficult situations and overcoming challenges to convey his message.

Self-confidence is identified as the third value in this context. Within the context of the film, a notable utterance can be observed from the character Lauriel, wherein she confidently declares, "I am a formidable warrior." The sentence was articulated with a notable display of confidence. The individual's response indicates a level of belief in the statements made by the other party. When individuals possess a conviction in the veracity of their statements, it can be posited that this phenomenon exhibits a form of educational merit, specifically in the realm of self-assurance. The term "confidence" is employed in this context to describe Lauriel's assertive and self-assured manner of speaking, intended to uplift her morale.

The fourth value, as identified in the context, is Kindness. In the cinematic production, Barley delivers a particular utterance, namely, "Stick your arm straight out the window to signal left," to his companion Ian. In the depicted scene, Barley assumes the role of an instructor, providing Ian with guidance on the operation of a vehicle. This assistance is rendered due to the urgent circumstances that the characters find themselves in. The depicted scene exhibits a notable manifestation of reciprocal assistance between the individuals involved. According to theoretical perspectives, when a speaker intends to assist another individual, their speech is regarded as embodying an educational value of kindness. The sentence can be classified as possessing a kindness value.

The concept of unselfishness is regarded as the fifth value in this context. According to one of the characters, the statement was made that the van in question was merely a dilapidated and wornout vehicle. The user's text expresses a sense of urgency or impatience, which may indicate a desire for prompt action or response. We must proceed with haste. The depicted scene portrays the character Barley willingly relinquishing possession of his cherished automobile to deliberately collide with a rock formation. This strategic maneuver utilizes the car as a barrier to impede the pursuit of law enforcement personnel. The action above indicates a manifestation of care, wherein one demonstrates concern for the well-being of others.

Additionally, it exemplifies sacrifice, as the individual willingly forgoes personal benefits or desires to prioritize the needs of others. Moreover, this action reflects unselfishness, as the person acts without seeking personal gain or recognition. Lauriel endeavored to provide emotional support to Ian and Barley, who were experiencing feelings of sadness and disillusionment during that particular period. According to Lauriel's statement, it can be inferred that she is considering the emotional distress experienced by the individuals in question. According to the theoretical framework, it is posited that when individuals take into account the emotions and sentiments of others, the act of embracing and acknowledging one's dissimilarities can be regarded as a form of educational virtue in the realm of respect. The sentence in question can be categorized under respect as it pertains to Lauriel's conscientious efforts to acknowledge and consider her children's emotions and sentiments.

The seventh value, as identified within the context, is love. During a particular scene in the film, one of the characters, Lauriel, addresses another character named Ian by uttering the following phrase: "Happy birthday, Mr. Adult Man. Hey buddy, please refrain from removing the affectionate imprints of my kisses." Lauriel Lightfoot cordially extends her congratulations to Ian on the occasion of his birthday, accompanied by a gentle peck on his cheek. The depicted scene effectively portrays the profound emotional bond between a maternal figure and her male offspring, exemplifying the fundamental human experience of love and affection within the context of the mother-son relationship. According to the theoretical framework, when a speaker articulates a discourse accompanied by corresponding actions that convey affection and devotion towards another individual, it can be posited that this particular manifestation can be categorized as an instance of the educational value of love.

The empirical analysis conducted on the film "Onward" reveals the presence of a comprehensive array of seven distinct moral values within its narrative framework. Through the act of viewing the film, individuals are subjected to the various values that are portrayed within its narrative. The film incorporates many scenes and dialogues that prominently feature actions and utterances that indicate various positive attributes such as honesty, bravery, self-confidence, kindness, unselfishness, respect, and love.

Movies have been recognized as a potent medium for expressing educational and moral values. The present research is underpinned by a multitude of studies, which have collectively demonstrated that moral values can be discerned within the realm of Korean dramas (Rosalina et al., 2023) as well as animated films (Purba et al., 2022)(Azi et al., 2022).

CONCLUSION

Onward, an animated film, encompasses numerous elements of moral value, rendering it a prominent research subject. Animated films of this nature have garnered significant attention as valuable research material, particularly concerning exploring moral values. The present study yielded a comprehensive analysis of the moral values depicted in the movie under investigation.
