#### Strengthening Islamic Value of Rahmatan Lil Aalamin for Lampung Society by the Indonesian Ulema Council (MUI)

#### **Abstract**

The purpose of this study is to determine the role of the Indonesian Ulema Council (MUI) in promoting Rahmatan Lil Aalamin values in Lampung society, which is diverse in terms of ethnic, religious, and cultural backgrounds. The concept of Rahmatan Lil Aalamin, which teaches Islam as a mercy to all nature without regard for ethnicity, religion, or race, is particularly relevant in a pluralistic society like Lampung. This study employs a qualitative approach, with data gathered through in-depth interviews, participatory observation, and documentation studies. The findings revealed that MUI actively engages in educating the public about the value of tolerance, justice, and unity through various educational programs, seminars, and social media. MUI also works with other religious organizations to improve understanding of religious moderation and Rahmatan Lil Aalamin principles. Although challenges such as radicalization and differences in religious understanding persist, Lampung's local wisdom, such as cooperation and deliberation, demonstrates the application of these values. Women play an important role in shaping the character of a tolerant generation. This study suggests that MUI should continue to strengthen inter-organizational cooperation and tap into the potential of local wisdom to create a more harmonious and inclusive society in Lampung.

#### Abstrak

Penelitian ini bertujuan untuk mengidentifikasi peran Majelis Ulama Indonesia (MUI) dalam penguatan nilai-nilai Rahmatan Lil Aalamin dalam masyarakat Lampung, sebuah provinsi dengan keberagaman suku, agama, dan budaya. Konsep Rahmatan Lil Aalamin, yang mengajarkan Islam sebagai rahmat bagi seluruh alam tanpa membedakan suku, agama, atau ras, sangat relevan dalam konteks masyarakat plural seperti Lampung. Penelitian ini menggunakan pendekatan kualitatif dengan teknik pengumpulan data melalui wawancara mendalam, observasi partisipatif, dan studi dokumentasi. This concept emphasizes the benefits of Islamic teachings for individuals and society and the blessings they bring to all creatures (Rohimat, 2018). Islam is a universal and comprehensive religion because it addresses every aspect of human life (Sirajudin, 2020).

Islam is a religion of peace that is relevant to the times (Yasin et al., 2024) because its teachings apply to all people. This value demonstrates that Islam is not incompatible with globalization but rather a universal religion that is a blessing to the universe. The term "*Rahmatan Lil Aalamin*" is directly from God in the Qur'an and refers to the Prophet Muhammad's teachings that have a positive, inclusive, comprehensive, and holistic impact. This concept is based on verse 107 of surah Al-Anbiya (Shihab & Sahabuddin, 2007).

Rahmatan Lil Aalamin emphasizes that Islam is a mercy for all people, regardless of religion, ethnicity, or race (Widasari, 2016). Lampung society is made up of various tribes, including Lampung, Java, Bali, and Batak, as well as religions like Islam, Christianity, Hinduism, and Buddhism. These differences promote tolerance and mutual respect. A society that practices Rahmatan Lil Aalamin is more likely to accept differences and avoid conflicts. Islam plays a critical role in achieving social harmony in Indonesia. Lampung Province has a diverse population of ethnicities, religions, and cultures. The majority of the population is Lampungese, but there are also Javanese, Balinese, Batak, Malay, and other ethnic groups who bring with them their traditions and cultures. The majority of the population is Muslim, followed by Christians, Hindus, Buddhists, and indigenous beliefs. This diversity is reflected in

MUI not only functions as a body or fatwa institution, but it also acts as a mediator in interfaith dialogue, promoting tolerance and encouraging cross-organizational cooperation. The research that is relevant to this research is a journal entitled "Islam Rahmatan Lil Aalamin in a Social and Cultural Perspective" by Khairan Muhammad Arif in 2021 (Arif, 2021). The aspect that makes this study unique is the difference in research methods. Solikhun's article "The Relevance of the Conception of Rahmatan Lil Aalamin to Religious Diversity" from 2021 is the next relevant research (Solikhun, 2021). However, this study did not go into detail about MUI's role in strengthening the Rahmatan Lil Aalamin concept. Agus Fatuh Widoyo has also conducted a study titled "Moderation of Religion in the Fatwa of

The objective of this research is to determine the role of the Indonesian Ulema Council (MUI) in promoting the values of *Rahmatan Lil Aalamin* in Lampung. This study also aims to present recommendations for MUI and the community to strengthen these values. Understanding the role of MUI and the challenges it faces will hopefully lead to the development of a more tolerant and harmonious Lampung society. As a result, the research question arises: how does the Indonesian Ulema Council (MUI) contribute to the strengthening of *Rahmatan Lil Aalamin* values in Lampung society?

#### **METHOD**

This research employs qualitative methods (Sugiyono, 2018). The qualitative method reveals data in the form of a person's or group's deep understanding, feelings, norms, values, beliefs, habits, mental attitudes, and culture toward everything (Bogdan & Biklen, 2015). The data was sourced from the primary and secondary data sources.

The primary data was gathered through in-depth interviews with religious and community leaders, participatory observation of MUI activities, and documentation of relevant reports and archives. Secondary data were gathered from literature sources. Data analysis was conducted thematically to better understand the role of MUI, the challenges encountered, and the implementation of *Rahmatan Lil Aalamin* values. A case study of the Lampung community served as the primary focus to demonstrate local wisdom and implementation of these values.

#### **RESULTS AND DISCUSSIONS**

Rahmatan Lil Aalamin literally translates to "mercy for the universe." In Islamic literature, the term Rahmatan Lil Aalamin refers to people of noble character who make positive contributions to society (Huda et al., 2022). According to Hasyim Asy'ari, Rahmatan Lil Aalamin is people who prioritize both personal interests and the well-being of others (Asy'ari, 2011). Given the ethnic and cultural

Furthermore, togetherness emphasizes the significance of cooperation and cooperation in achieving shared goals. Another value in Rahmatan Lil Aalamin is togetherness, which emphasizes the value of collaboration and cooperation in achieving common goals. Togetherness fosters community solidarity as members assist and support one another in achieving common goals. Tolerance is not easy to achieve, but with a strong intention, willingness to listen, and mutual respect, religious differences that can initially cause conflict can be transformed into a force for building a more inclusive, harmonious, and peaceful society.

#### Case Study of Rahmatan Lil Aalamin Implementation in Lampung Society

The application of *Rahmatan Lil Aalamin* values in Lampung culture is evident in the existing local wisdom. According to Pranoto and Wibowo, Lampung traditions include values such as cooperation and deliberation. These practices embody the spirit of community and mutual respect that is central to *Rahmatan Lil Aalamin* (Pranoto & Wibowo, 2018). By incorporating these values into daily life, Lampung people can create a harmonious and tolerant environment.

In this context, cooperation demonstrates the community's willingness to collaborate for the common good. In contrast, deliberation emphasizes the importance of reaching an agreement through peaceful dialogue and respect for all viewpoints. Both, in a deeper sense, are manifestations of the *Rahmatan Lil Aalamin* principle, which teaches that Islam, as a religion of mercy, is for the entire universe, with compassion, justice, and peace.

These practices demonstrate how Lampung people have long internalized the universal values embodied in Islamic teachings, albeit within the context of their local knowledge (Kesuma et al., 2023). For example, in every important meeting or event, Lampung people prioritize deliberation, allowing everyone to express their views. This is how they maintain harmony and avoid conflict in accordance with the value of grace, which promotes mutual respect and the avoidance of hostility. Similarly, cooperation, in which people work together regardless of ethnicity, religion, or social status, exemplifies Islam's teachings about unity and togetherness in diversity.

Integrating *Rahmatan Lil Aalamin* values into Lampung's daily lives is not difficult. Existing local wisdom provides a solid foundation for strengthening these teachings. For example, activities such as house construction or environmental
